Only primary vendors and VIPs may buy from other vendors during load-in. No musical related product or service transactions may be conducted in parking area outside the CCGS venue during show and load-in hours. CCGS accepts no responsibility for any transactions between vendors and buyers. Each vendor is responsible for their own property from load-in to load-out and any insurance covering same. CCGS promoter and staff will not be responsible for any personal injury or property damage, theft, or loss to vendors, vendor helpers or staff, or vendor property during CCGS. Vendor badges must be worn at all times during load-in, show time, and load-out. Vendor badges are not transferable. Vendors must adhere to booth noise restrictions based on common courtesy to others, but ultimately will be at the discretion of the CCGS promoter and staff. Vendors are expected to staff and operate their booth until close of show. Vendor load-out must be completed by 5pm. Each vendor is responsible for all applicable city, state, and federal laws, ordinances, taxes, fees, and fines while participating in the CCGS. **Each vendor selling merchandise must complete a California State Board of Equalization BOE-410-D form** showing status as holder of valid seller's permit or being exempt from holding a seller's permit (not applicable to returning vendors who have previously provided form and license is current). No merchandise or service may be displayed or sold that is illegal or deemed inappropriate by CCGS. No smoking, alcohol, or animals allowed in show building.
